





Parent Writing Workshop

"We Laughed and Cried Together"

In January, 2015 eight strangers walked into the Start Your Story writing workshop as complete strangers, not knowing that 4 months later we would all become the best of friends.

The purpose of the class was to share how Mental Health experiences affected the lives of our families. It was a relief and an eye opening experience to hear that we were all going through similar situations, some more intense than others.

The class was taught by a UCF intern pursuing her Master's degree and we met every Friday for 2 hours. She did a great job of helping us express our experiences with Mental Health. One of the techniques she used was the five senses: hearing, touching, smelling, seeing and tasting. This method helped us to dig deeper into our memories and describe in detail exactly our thoughts and feelings.

At the end, we read each other's stories. We shared our hopes and our fears for our families. We laughed and cried together. Today we remain the best of friends.
